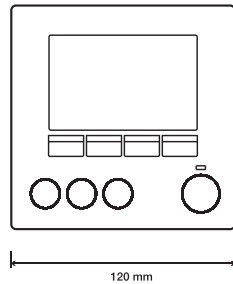

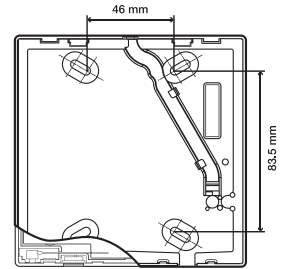
Front View
