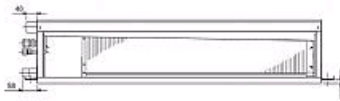

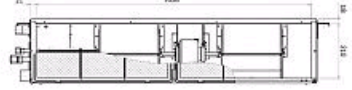

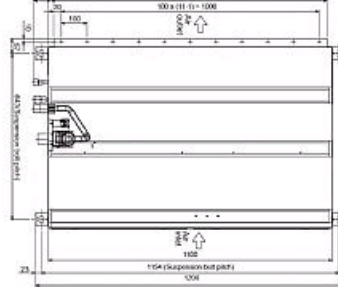
Front View >



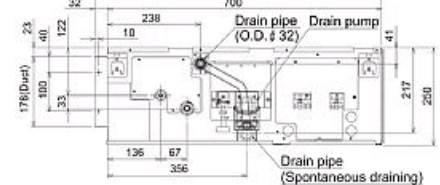
Rear View >

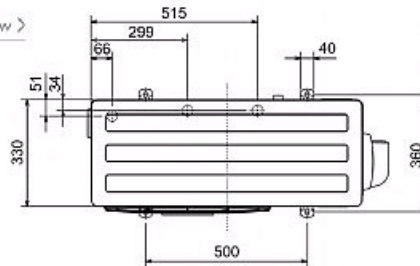

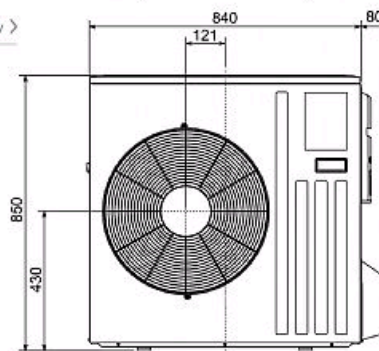

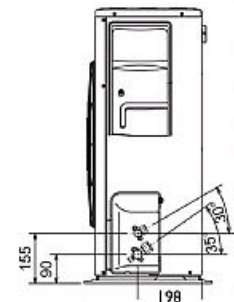
